**TERMINATION AND RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY**

**THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of September 1, 2022, is made by **PNC BANK, NATIONAL ASSOCIATION**, (as successor to BBVA USA, an Alabama banking corporation f/k/a Compass Bank), in its capacity as Administrative Agent for the Secured Parties ("Agent"), under that certain Intellectual Property Security Agreement, dated as of November 17, 2020, by **MAPLE LIFE FINANCIAL, LLC**, a Delaware limited liability company ("Grantor"), in favor of Agent (as amended, supplemented or modified and in effect from time to time, the "IP Security Agreement"). Capitalized terms used but not defined herein shall have the meanings set forth in the IP Security Agreement.

**WHEREAS**, pursuant to the IP Security Agreement, Grantor granted a security interest to Agent (for benefit of the Secured Parties) in the Collateral including the Trademarks set forth on Schedule I thereto (collectively, the "IP Collateral"); and

**WHEREAS**, an executed copy of the IP Security Agreement was recorded with the Assignment Recordation Branch, Public Records Division of the United States Patent and Trademark Office on November 18, 2020 at Reel 7110, Frame 0070; and


**WHEREAS**, Agent has agreed to terminate and release its security interest in all of such IP Collateral, including, without limitation, the Trademarks identified on Exhibit A attached hereto, being the same Trademarks set forth on Schedule I to the IP Security Agreements.

**NOW, THEREFORE**, for good and valuable consideration, the receipt of which is hereby acknowledged, Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the IP Security Agreements in the IP Collateral, (b) release its security interest in the IP Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Agent in the IP Collateral.
