## NUNC PRO TUNC ASSIGNMENT OF TRADEMARKS

This Nunc Pro Tunc Assignment of Trademarks (the "Assignment") is made by and between American Management Association International, a New York not-for-profit corporation having a principal place of business at 1601 Broadway, New York, New York 10019, United States of America ("Assignor"), and HarperCollins Christian Publishing, Inc., a Tennessee corporation having a principal place of business at 501 Nelson Place, Nashville, Tennessee 37214, United States of America ("Assignee"), and is effective as of March 2, 2018 (the "Effective Date").

WHEREAS, Assignor and Assignee entered into an Asset Purchase Agreement dated February 22, 2018 (the "Purchase Agreement");

WHEREAS, pursuant to the Purchase Agreement, Assignor transferred to Assignee all right, title, and interest of Assignor in and to the Acquired Intellectual Property (as such term is defined in the Purchase Agreement) (the "Assigned IP"); and

WHEREAS, the Assigned IP included the trademarks identified on the attached Exhibit A, (the "Marks").

NOW, THEREFORE, for good and valuable consideration received by Assignor from Assignee, the receipt and sufficiency of which is hereby acknowledged, the parties agree and reconfirm as follows:

1. Assignment of Marks. Assignor sold, transferred, and assigned to Assignee, its successors and assigns, all of Assignor's right, title, and interest in the Marks as they existed anywhere in the world and as may be created or acquired at any date in the future, together with that part of the goodwill of the business associated with the use of and symbolized by the Marks. This assignment included without limitation all applications and registrations for the Marks, all priority rights or claims based on international conventions, all rights to proceeds of the Marks, including income, royalties, fees, damages, profits, and payments then or thereafter payable, all rights of action of Assignor, and the right to take proceedings and to seek damages and all other available remedies, against third parties for past, present, or future infringement, dilution, misappropriation, violation, misuse, breach, or default, of the Marks, including the right to any equitable relief recoverable, *Nunc Pro Tunc*, effective as of the Effective Date.

2. Recordation of Assignment. Assignor hereby authorizes the appropriate empowered officials at the United States Patent and Trademark Office and all other relevant international intellectual property offices to transfer all applications and registrations for the Marks to Assignee as assignee of the entire right, title and interest therein or otherwise as Assignee may direct, in accordance with this instrument of assignment.

3. Cooperation. Assignor hereby covenants and agrees to cooperate with Assignee so that Assignee may enjoy to the fullest extent the rights, title, and interest herein conveyed. Such cooperation shall include prompt execution of all papers prepared at the expense of Assignee which are deemed necessary or desirable by Assignee to perfect in it the rights, title, and interest herein conveyed.

4. Governing Law and Venue. This Assignment shall be governed and construed in accordance with the Laws of the State of New York applicable to contracts to be wholly performed within the State of New York, without regard to the laws of any other jurisdiction that might be applied because of the conflicts of laws principles of the State of New York (other than Section 5-1401 of the New York General Obligations Law). This Assignment and the duties and obligations of Assignor and Assignee

hereunder shall be enforceable against such person in the courts of the United States of America located in the County of New York and in the courts of the State of New York located in the County of New York. For such purpose, Assignor and Assignee hereby irrevocably submit to the non-exclusive jurisdiction of such courts, and agree that all claims in respect of this Assignment shall be heard and determined in any of such courts. Assignor and Assignee hereby irrevocably agree that a final unappealable judgment of any of the courts specified above in any action or proceeding relating to this Assignment shall be conclusive and may be enforced in other jurisdictions by suit on the judgment or in any other manner provided by Law.

5. Counterparts. This Assignment may be executed in one or more counterparts, all of which shall be considered one and the same agreement and shall become effective when counterparts have been signed by each of the parties and delivered to the other parties. This Assignment may be executed by facsimile or electronic transmission signature and such signature shall constitute an original for all purposes.

6. Purchase Agreement Shall Control. Nothing in this Assignment shall change, amend, limit, extend or alter (nor shall it be deemed or construed as changing, amending, extending or altering) the terms or conditions of the Purchase Agreement or any liability or obligation of the Assignor or Assignee arising under the Purchase Agreement, which shall govern the representations, warranties and obligations of the parties with respect to the Assigned IP. In the event that any of the provisions of this Assignment are determined to conflict with the terms of the Purchase Agreement, the terms of the Purchase Agreement shall control.






