## RELEASE OF SECURITY INTEREST IN INTELLECUAL PROPERTY

This Release of Security Interest in Intellectual Property is made as of September [2], 2022, by CRG SERVICING LLC, a Delaware limited liability company, as administrative agent and collateral agent (in such capacities, together with its successors and assigns, “*Administrative Agent*”) in favor of ALIGNMENT HEALTHCARE USA, LLC, a Delaware limited liability company (“*Grantor*”).

### Recital

WHEREAS, Grantor granted to Administrative Agent a security interest in substantially all of its personal property, including, but not limited to, the trademarks and trademark applications described on Exhibit A hereof (the “*Intellectual Property*”) under that certain Security Agreement, dated as of August 21, 2018 (as amended, restated, amended and restated, supplemented, and/or otherwise modified from time to time, the “*Security Agreement*”);

WHEREAS, Administrative Agent perfected its security interest over the Intellectual Property by recording a Trademark Security Agreement, dated as of July 3, 2018 (the “*Trademark Security Agreement*”), with the United States Patent and Trademark Office as set forth on Exhibit A;


WHEREAS, Grantor has requested, and Administrative Agent has agreed, to release its security interest in the Intellectual Property and terminate the Trademark Security Agreement.

### Agreement

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of itself, the Lenders and their successors, legal representatives and assigns, hereby unconditionally, irrevocably and absolutely agrees that it terminates and releases its security interest in the Intellectual Property, terminates the Trademark Security Agreement, and reassigns to Grantor, without warranty or recourse, all interest of Administrative Agent in the Intellectual Property.


