RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST (the "Release") is made and effective as of Sept. 2, 2022, and is granted by VILLAGE BANK AND TRUST, an Illinois corporation (the "Bank"), on behalf of itself and its successors and assigns, in favor of VOSGES IP, LLC, an Illinois limited liability company (the "Debtor"), together with its successors and assigns.

WHEREAS, pursuant to that certain Continuing Security Agreement dated February 23, 2015, and any amendments thereto (the "Security Agreement"), the Debtor granted to the Bank a security interest in and lien upon certain collateral, which collateral includes without limitation those trademarks listed on Schedule A to this Release;

WHEREAS, the Security Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office (the "USPTO") on February 23, 2015, at Reel 005470, Frame 0433; and

WHEREAS, the Debtor has requested that the Bank grant this Release in order to effectuate, evidence and record the release to the Debtor of any and all right, title and interest the Bank may have in trademarks, including those trademarks listed on Schedule A to this Release, and the Bank has so agreed.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Bank hereby agrees and states as follows:

A. Release of Security Interest. The Bank, on behalf of itself and its successors and assigns, hereby:

1. terminates, releases, assigns, transfers, quitclaims, and conveys to Debtor any and all liens, security interests, right, title and interest of the Bank, its successors and assigns, in any and all of trademarks of Debtor, and its successors and assigns, and all applications or registrations therefor, including those trademarks identified in Schedule A annexed hereto and made a part hereof;

2. agrees that any power of attorney or similar rights granted by Debtor to the Bank pursuant to or in connection with the Security Agreement is terminated; and

3. authorizes and requests that the USPTO record the release hereby given.


B. Exclusion. This Release does not, and shall not be interpreted to, include any assignment or transfer of any "intent to use" trademark application if, and only to the extent that, and solely during any period within which, any provision herein would impair the validity or enforceability, or result in the cancellation or voiding, of such application or registration issuing therefrom, or any trademark covered thereby or associated therewith.

C. Further Assurances. The Bank agrees, at the Debtor's expense, to take all further actions, and provide to the Debtor all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Debtor may reasonably request in order to confirm, effectuate or record this Release.
