**RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT
(TRADEMARKS)**

This RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (the "Release") is effective as of the 6th day of September, 2022, by and between:

SCINAPSIS ANALYTICS INC., a corporation existing under the Canada Business Corporations Act ("Grantor"), and

COMERICA BANK, a Texas banking association and authorized foreign bank under the Bank Act (Canada) (in such capacity, together with its successors and assigns, if any, in such capacity, "Bank").

WITNESSETH:

A. Grantor and Bank entered into that certain Loan Agreement dated as of February 27, 2019 (as amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement").

B. All of the present and future Obligations of Grantor, including, without limitation, reasonable attorneys' fees and expenses and any interest, fees or expenses that accrue after the filing of an insolvency proceeding, regardless of whether allowed or allowable in whole or in part as a claim in any insolvency proceeding (all of the foregoing, collectively, the "Secured Obligations"), were secured by the assets of Grantor, including, without limitation, all of Grantor's patents, trademarks, copyrights and other intellectual property.

C. Grantor and Bank entered into that certain Intellectual Property Security Agreement dated as of February 27, 2019, which was recorded with the United States Patent and Trademark Office ("PTO") on March 11, 2019, at Reel 6587, Frame 0493 (the "Trademarks Assignment").

D. Grantor has satisfied all of the Secured Obligations under the Loan Agreement and requested that the Bank terminate and release its security interests in and liens on the Intellectual Property.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) Definitions. All capitalized terms not defined in this Release shall have the respective meaning given to them in the Loan Agreement or the Trademarks Assignment, as the case may be.

2) Termination and Release of Security Interest. The Bank hereby irrevocably terminates, releases, and discharges its security interest in and liens on the Intellectual Property, including, without limitation, the Trademarks listed on Exhibit A hereto, and the Bank hereby assigns and transfers to the Grantor, without representation, warranty or recourse, all of the Bank's right, title and interest in and to such Trademarks, effective as of the date set forth above.

3) USPTO. Bank authorizes and requests that the Commissioner of the United States Patent and Trademark Office and any other applicable government authority record this Release.
