TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement") is effective as of October 19th, 2021 (the "Effective Date") by and between Mission Pharmacal Company, a corporation duly formed and validly existing under the laws of the State of Texas with its principal business address being at 10999 Interstate Highway 10 West, Suite 1000, San Antonio, Texas 78230 ("Assignor"), and Alpha Scrip, Inc., a corporation duly formed and validly existing under the laws of the State of Arizona with its principal business address being at 5080 N. 40th Street 339, Phoenix, AZ, 85018 ("Assignee"). The Assignor and the Assignee are also referred to in this Agreement individually as a "party" and collectively as the "parties."

RECITALS:

WHEREAS, Assignor is the owner in the United States of the trademark of "AQUORAL" and associated registration in the United States under trademark registration number 5,103,779 with the United States Patent and Trademark Office (the "Mark").

WHEREAS, Assignee desires to acquire all of Assignor's rights, title and interest in and to the Mark, including any and all goodwill relating thereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto intending to be legally bound do hereby agree as follows:

1. Assignment. Assignor hereby sells, assigns, transfers and conveys to Assignee, absolutely and in perpetuity, all of Assignor's rights, title, and interests in and to the Mark, together with all of the goodwill associated therewith and the right to recover for past infringement of the Mark. This Agreement has been duly approved by all necessary action by each of Assignor and Assignee.


