This **ASSIGNMENT OF COPYRIGHT, PATENT AND TRADEMARK SECURITY AGREEMENTS** (this “Assignment”), dated as of August 29, 2022, is by **CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH** (individually, “CS”), acting in its capacity as the former administrative agent (in such capacity, the “Retired Agent”) and **CORTLAND CAPITAL MARKET SERVICES LLC** (individually, “Cortland”), acting in its capacity as the successor administrative agent (in such capacity, the “Successor Agent”).

RECITALS:

WHEREAS, Panavision Inc. (“Panavision”) and Panavision International, L.P. (“PILP”), each as “Grantor”, and Retired Agent are parties to that certain First Lien Patent Security Agreement and that certain First Lien Trademark Security Agreement, each identified in Exhibit A attached hereto (as the same have been and may hereafter be amended, restated, supplemented or otherwise modified from time to time, collectively, the “Panavision-PILP Agreements”), and Panavision, as “Grantor” and Retired Agent are parties to that certain Copyright Security Agreement, identified in Exhibit B attached hereto (as the same have been and may hereafter be amended, restated, supplemented or otherwise modified from time to time, the “Panavision Agreement” and together with the Panavision-PILP Agreements, the “Agreements”), covering certain intellectual property set forth on Exhibit C attached hereto; and

WHEREAS, pursuant to that certain Successor Agent Agreement and Third ARCA Amendment No. 1, dated as of August 20, 2015 (the “Successor Agreement”), by and among Panavision, certain financial institutions party thereto, the Retired Agent and the Successor Agent, which appointed the Successor Agent as the administrative agent under that certain Third Amended and Restated Lien Credit Agreement, dated as of February 12, 2015, by and among the parties to the Panavision, certain subsidiaries of Panavision, certain financial institutions party thereto and the Successor Agent, the Retired Agent assigned to Successor Agent all of its rights, remedies, duties and other obligations under, among other documents, the Agreements, in each instance, in its capacity as administrative agent.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Retired Agent hereby assigns and transfers to Successor Agent and its successors and assigns, all of its rights, title and interest in and to the Agreements.


This Assignment may be executed in any number of counterparts, each of which when so executed shall be deemed an original and all of which taken together shall constitute one and the same instrument.


