Delaware Limited Liability Company Act

Popcornopolis, LLC, a Delaware limited liability company, ("Terminating LLC"), and Barcel USA, LLC, a Texas limited liability company ("Surviving LLC"), do hereby certify to the following facts relating to the merger ("Merger") of the Terminating LLC with and into the Surviving LLC.

1. The names and states of formation of the constituent legal entities of the Merger are Popcornopolis, LLC, which was organized pursuant to the Delaware Limited Liability Company Act, and Barcel USA, LLC, which was organized pursuant to the Texas Limited Liability Company Act.

2. An Agreement and Plan of Merger ("Agreement") between the parties to the Merger has been approved, adopted, certified, executed and acknowledged by the Surviving LLC and the Terminating LLC as required by the laws of each of the jurisdictions of formation and the forming documents of each organization.

4. The Certificate of Formation of the Surviving LLC shall continue in full force and effect as its Certificate of Formation.

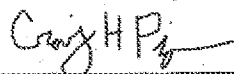
5. The effective date of the merger is August 1, 2022.
