On April 22, 2021, ICON Health & Fitness, Inc. and Force Impact Technologies, Inc. executed a settlement agreement concerning the terms of their coexistence and settlement of claims, wherein the parties agreed that should the FITAPP and FITCLOUD trademark applications register, the entire interest and the goodwill in the FITAPP and FITCLOUD registrations to ICON Health & Fitness, Inc.

6. The executed settlement agreement included the unexecuted Attachment A Trademark Assignment that was later executed on June 8, 2022.

NAME CHANGE

7. On August 9, 2021, at 5:23 p.m., ICON Health & Fitness, Inc. changed its name to iFIT Inc.


