Such right, title and interest shall be held and enjoyed by Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made.

The provisions of this instrument are subject, in all respects, to the terms and conditions of the Agreement including, without limitation, all of the covenants, representations and warranties contained therein, all of which shall survive the execution and delivery of this instrument to the extent indicated in the Agreement. Nothing contained in this instrument shall be deemed to modify, amend or supersede any of the terms or conditions of the Agreement. In the event of any conflict or inconsistency between the terms and conditions of this instrument and the terms and conditions of the Agreement, the terms and conditions of the Agreement shall prevail. This instrument shall be binding upon Assignor, its successors and assigns, and shall inure to the benefit of Assignee, its successors and assigns.
