ASSIGNOR does also hereby sell, assign and transfer unto ASSIGNEE, its successors and assigns all claims for damages by reason of past and present infringement of the TRADEMARK, including the trademark rights established by use, the registrations and applications, and the right to sue for and collect damages and other relief; and


ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States to record the right to the Trademark as the property of ASSIGNEE; and

This assignment is made effective 18 August 2022






