**TERMINATION AND RELEASE OF SECURITY
INTEREST IN PATENTS AND TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS**, dated as of September 7, 2022 (“Release”), is made by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, (“Lender”), in favor of **NATIONAL SPINNING CO., INC.**, a North Carolina corporation (“Parent”), **NATIONAL SPINNING OPERATIONS, LLC**, a North Carolina limited liability company (“Operations”), **CAROLINA NONWOVENS, LLC**, a North Carolina limited liability company (“Nonwovens”), and **HAMPTON ART, INC.**, a Delaware corporation (“Hampton”) (Parent, Operations, Nonwovens, and Hampton are sometimes referred to herein individually as a “Company” and collectively as “Companies”).

WHEREAS, pursuant to that certain Patent and Trademark Security Agreement dated as of September 7, 2017, among the Companies and Lender (the “Security Agreement”), each Company granted to the Lender, for the benefit of the Lenders, a continuing security interest in all right, title and interest of each Company in and to all (a) Patents, including the Patents identified on the attached Schedule A and (b) Trademarks including the Trademarks identified on the attached Schedule B; and

WHEREAS, the security interest identified herein was recorded with the United States Patent and Trademark Office (“USPTO”) on September 12, 2017, at Reel 6152 Frame 0744.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender and each Company agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement referenced in the preamble and recitals hereto.

SECTION 2. Termination and Release. Lender without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:


- (a) terminates, cancels, forever discharges and releases the continuing security interest in, each Company’s right, title, and interest in and to (i) the Patents identified on Schedule A attached hereto and (ii) the Trademarks identified on Schedule B attached hereto, in each case, granted pursuant to the Security Agreement;
- (b) retransfers and reconveys to Companies any and all of the rights, title, and interest it may have in and to the Patents and Trademarks; and
- (c) authorizes the recordation of this Release with the USPTO at the Companies’ expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of Georgia.
