ARTICLES OF ENTITY CONVERSION

OF

TECH OIL PRODUCTS, INC.

Pursuant to the Louisiana Revised Statutes Sections, Tech Oil Products, Inc., a Louisiana corporation, hereby submits the following Articles of Entity Conversion for the purpose of converting into Tech Oil Products, LLC, a Louisiana limited liability company (such conversion, the "Conversion").

1. The name of the converting entity is Tech Oil Products, Inc., a Louisiana corporation (the "Converting Corporation"). The name of the converted entity will be Tech Oil Products, LLC, which shall be a Louisiana limited liability company (the "Converted Entity") governed by Louisiana Revised Statutes 1301, *et seq.*

2. The Converting Corporation is continuing its existence in the organizational form of the Converted Entity.

4. The Plan of Conversion has been authorized and approved by the Shareholders of the Converting Corporation in accordance with 12:1-953A of the Louisiana Revised Statutes and the Articles of Incorporation of the Converting Corporation.

5. The Articles of Organization of the Converted Entity are as follows:

A. The name of the limited liability company is Tech Oil Products, LLC (the "Company").

B. The Company may engage in any lawful activity for which limited liability companies may be formed under Chapter 22, Title 12, of the Louisiana Revised Statutes.

C. The period of duration of the Company is perpetual.


