ARTICLES OF ENTITY CONVERSION  
OF  
KNOWWHO, INC.

The undersigned, on behalf of KnowWho, Inc., pursuant to Title 13.1, Chapter 9, Article 12.2 of the Virginia Stock Corporation Act (the "VSCA"), states as follows:


1. The name of the corporation immediately prior to the filing of these Articles of Entity Conversion is KnowWho, Inc. (the "Company"). The Company shall convert to a Virginia limited liability company and its name shall be KnowWho, LLC (the "LLC").
2. The Company was originally incorporated on May 7, 1999 as a Virginia corporation with the name KnowWho, Inc.
3. The Plan of Entity Conversion, pursuant to Section 13.1-722.10 of the VSCA, including the full text of the Articles of Organization of the LLC to take effect immediately after the Effective Time (defined below) are attached hereto as Exhibit A.
4. The Plan of Entity Conversion was approved by the Company's sole shareholder pursuant to Section 13.1-657 of the VSCA on November 24, 2020.
5. These Articles of Entity Conversion shall be effective at 5:00 p.m. on November 25, 2020 (the "Effective Time").

**PLAN OF ENTITY CONVERSION**

**OF**

**KNOWWHO, INC.,  
A VIRGINIA CORPORATION**

**INTO**

**KNOWWHO, LLC,  
A VIRGINIA LIMITED LIABILITY COMPANY**

1. *Conversion.* KnowWho, Inc., a Virginia corporation (the "Company"), shall convert into KnowWho, LLC, a Virginia limited liability company (the "LLC"), in accordance with this Plan of Entity Conversion (the "Conversion"). The Conversion shall be effective at such time as is set forth in the Articles of Entity Conversion (the "Effective Time").

2. *Manner and Basis of Conversion of Common Stock Into Membership Interest.* At the Effective Time, each outstanding share of common stock of the Company shall, by virtue of the Conversion and without any action on the part of the Company or the shareholders of the Company, be changed and converted automatically into a membership interests in the LLC on a one-for-one basis. The ownership proportion of each shareholder and the relative rights, preferences and limitations of each share shall be unaffected by the Conversion.

3. *Articles of Organization.* The Articles of Organization attached hereto as Exhibit A shall be the Articles of Organization of the LLC at the Effective Time and thereafter until duly amended in accordance with their terms and the Virginia Limited Liability Company Act.

4. *Effect of Conversion.* At the Effective Time, the Conversion shall have the effect stated in Section 13.1-722.13 of the Virginia Stock Corporation Act.


5. *Abandonment and Amendment.* To the fullest extent permitted by law, the Conversion may be abandoned, and this Plan of Entity Conversion may be amended, by vote of a majority of the Board of Directors of the Company at any time prior to the Effective Time.

ARTICLES OF ORGANIZATION  
OF  
KNOWWHO, LLC

Pursuant to Chapter 12 of Title 13.1 of the Code of Virginia, KnowWho, LLC states as follows:

1. The name of the limited liability company is KnowWho, LLC.
2. The name of the limited liability company's initial registered agent is Bruce B. Brownson, a resident of the Commonwealth of Virginia and a member of the Company.
3. The limited liability company's initial registered office address, which is identical to the business office of the initial registered agent, is 3201 Cunningham Dr., Alexandria, Virginia, 22309-2210, located in Fairfax County, Virginia.
4. The limited liability company's principal office address, including the street and number, is 8245 Backlick Road, Suite F2, Lorton, VA 22079-1445.
