THIS AGREEMENT AND THE RIGHTS AND OBLIGATIONS EVIDENCED HEREBY ARE SUBORDINATE IN THE MANNER AND TO THE EXTENT SET FORTH IN THAT CERTAIN SUBORDINATION AND INTERCREDITOR AGREEMENT (AS THE SAME MAY BE AMENDED, RESTATED, SUPPLEMENTED OR OTHERWISE MODIFIED FROM TIME TO TIME PURSUANT TO THE TERMS THEREOF, THE “INTERCREDITOR AGREEMENT”) DATED AS OF JULY 11, 2022 AMONG AGS COMPANY AUTOMOTIVE SOLUTIONS, LLC, A DELAWARE LIMITED LIABILITY COMPANY (THE “COMPANY”), THE OTHER LOAN PARTIES PARTY THERETO, THE SECURED PARTY (AS DEFINED BELOW) AND JPMORGAN CHASE BANK, N.A. (“SENIOR CREDITOR”), TO THE INDEBTEDNESS (INCLUDING INTEREST) OWED BY THE LOAN PARTIES PURSUANT TO THAT CERTAIN CREDIT AGREEMENT DATED AS OF NOVEMBER 17, 2016 AMONG THE COMPANY, THE OTHER LOAN PARTIES, AND SENIOR CREDITOR, AND THE OTHER SENIOR LOAN DOCUMENTS (AS DEFINED IN THE INTERCREDITOR AGREEMENT), AS SUCH CREDIT AGREEMENT AND SUCH SENIOR LOAN DOCUMENTS HAVE BEEN AND HEREAFTER MAY BE AMENDED, RESTATED, SUPPLEMENTED OR OTHERWISE MODIFIED FROM TIME TO TIME AND TO INDEBTEDNESS REFINANCING THE INDEBTEDNESS UNDER SUCH AGREEMENTS, IN EACH CASE TO THE EXTENT PERMITTED BY THE INTERCREDITOR AGREEMENT; AND EACH PARTY TO THIS AGREEMENT, BY ITS ACCEPTANCE HEREOF, IRREVOCABLY AGREES TO BE BOUND BY THE PROVISIONS OF THE INTERCREDITOR AGREEMENT.

INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement, dated as of July 11, 2022 (this “Agreement”), is made by each of the undersigned (each, a “Grantor”), in favor of Muzinich BDC, Inc. (the “Secured Party” and, together with the Grantors, the “Parties” and each, a “Party”).

Each Grantor is party to the Second Lien Security Agreement dated as of July 11, 2022 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), made by each Grantor in favor of the Secured Party pursuant to which each Grantor granted a security interest to the Secured Party in certain of its assets.

Each Grantor is executing and delivering this Agreement for recording with national, federal and state governmental authorities, including the United States Patent and Trademark Office and/or the United States Copyright Office.

In consideration of the foregoing and the mutual agreements contained in this Agreement, the receipt and sufficiency of which are acknowledged, the Parties hereby agree as follows:

1. Confirmation of Security Interest. Each Grantor confirms that, pursuant to the Security Agreement, it granted to the Secured Party a security interest in all of its right, title and interest in, to and under all of the property described therein, whether now existing or hereafter from time to time acquired and wherever located, including the items listed on Schedule 1, Schedule 2 and Schedule 3 and all proceeds, supporting obligations and products of any of the

foregoing and all collateral security and guarantees given by any person or entity with respect to any of the foregoing.

2. Acknowledgement. Each Grantor acknowledges and affirms that the rights and remedies of the Secured Party with respect to the security interests in the property described in Section 1 are more fully set forth in the Security Agreement. In the event that any provision of this Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement control. The Security Agreement (and all rights and remedies of the Secured Party thereunder) remains in full force and effect in accordance with its terms.

3. Recordation. This Agreement has been executed and delivered by each Grantor for the purpose of recording the grant of a security interest with national, federal and state governmental authorities, including the United States Patent and Trademark Office and/or the United States Copyright Office. Each Grantor authorizes any government officials to record and register this Agreement upon request by the Secured Party.

4. Authorization to Supplement. Each Grantor authorizes the Secured Party to unilaterally modify this Agreement by amending Schedule 1, Schedule 2 or Schedule 3 to include any registrations of and applications for registration or issuance for each Grantor's Patents, Trademarks or Copyrights (each as defined in the Security Agreement) not previously set forth on such schedules and that are otherwise covered by the Security Agreement. Notwithstanding the foregoing, no failure to modify this Agreement or amend Schedule 1, Schedule 2 or Schedule 3 in any way affects, invalidates or detracts from the Secured Party's continuing security interest in any property described in Section 1, whether or not listed on Schedule 1, Schedule 2 or Schedule 3.


5. Successors and Assigns. This Agreement is binding upon, and inures to the benefit of, the Parties and their respective successors and permitted assigns. Nothing in this Agreement, expressed or implied, may be construed to confer upon any person or entity (other than the parties hereto, their respective successors and permitted assigns) any legal or equitable right, remedy or claim under or by reason of this Agreement.

6. Counterparts. This Agreement may be executed in counterparts (and by different parties hereto in different counterparts), each of which constitutes an original, but all of which when taken together constitute a single contract. Delivery of an executed counterpart of a signature page of this Agreement by facsimile or other electronic transmission is as effective as delivery of a manually executed counterpart of this Agreement.
