**TERMINATION OF SECURITY INTEREST  
IN TRADEMARKS**

THIS TERMINATION OF SECURITY INTEREST IN TRADEMARKS is made effective as of September 12, 2022 by Eagle Fund III, L.P. and Eagle Fund III-A, L.P. (the "Lenders").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of July 30, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), by Multi-Comp, Inc., a Virginia corporation (the "Debtor") in favor of the Lenders, the Debtor granted to the Lenders a second priority security interest in all of Debtor's right, title, and interest in, to, and under the Collateral (as defined in the Trademark Security Agreement), including, without limitation, the trademarks listed on Schedule A;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on July 30, 2015 at Reel/Frame 5588/0550;

WHEREAS, Debtor has requested that the Lenders release their security interest in the Collateral and reassign any and all rights in the same to Debtor;

WHEREAS, Debtor has satisfied and fulfilled all of its obligations to release the security interests in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lenders hereby terminate, release, discharge and disclaim, any lien, security interest, pledge and/or assignment created in its favor in the Collateral, and releases all of the Lenders' right, title and interest in said Collateral, including without limitation, the trademarks and trademark applications listed on Schedule A hereto.


The Lenders agree to provide the Debtor with any information and additional authorization necessary to effect the release of Lenders' security interest in the Trademark Collateral.


