RELEASE OF SECURITY INTEREST IN TRADEMARKS

RELEASE OF SECURITY INTEREST IN TRADEMARKS, effective as of September 12, 2022, given by COÖPERATIEVE RABOBANK U.A., NEW YORK BRANCH (formerly known as COÖPERATIEVE CENTRALE RAIFFEISEN-BOERENLEENBANK B.A. "Rabobank Nederland", New York Branch), in its capacity as administrative agent for the Lenders (in such capacity, the "Administrative Agent"), with its principal offices at 245 Park Avenue, New York, New York 10167, to Consolidated Coffee, Inc., a Delaware corporation ("Parent") and Eight O'Clock Coffee Company, a Delaware corporation ("EOC"), ("EOC," jointly and severally with Parent, the "Grantors," and each individually, a "Grantor"), as follows:

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of October 31, 2008 ("Security Agreement"), made by each Grantor in favor of Administrative Agent, a security interest was granted by EOC to Administrative Agent in certain trademarks and trademark applications (the "Trademarks"), including without limitation those items listed on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent & Trademark Office on October 31, 2008, at Reel 003880, Frame 0795; and

WHEREAS, Administrative Agent now desires to release the entirety of its security interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Administrative Agent hereby terminates the Security Agreement and releases and discharges unto EOC the continuing security interest in, and any other interest Administrative Agent may have in EOC's right, title and interest in, the Trademarks.


