RELEASE OF CONFIRMATORY GRANT OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF CONFIRMATORY GRANT OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is granted as of August 31, 2022, to ROLLEASE ACMEDA PTY LTD (ACN 602 498 395), a company organized under the laws of Australia (the “Grantor”), by and from U.S. BANK NATIONAL ASSOCIATION, a national banking association (the “Secured Party”), for itself and as administrative agent for the Lenders (as defined in the Australian Security Agreements referenced below).

WHEREAS, the Grantor has granted security interests to the Secured Party under (i) that certain General Security Deed (All Assets), dated as of August 29, 2018, among the Grantor, Rollease Acmeda Holdings Pty Ltd and the Secured Party, and (ii) that certain General Security Deed (With Exceptions), dated as of August 29, 2018, among the Grantor, Rollease Acmeda Holdings Pty Ltd and the Secured Party (each, an “Australian Security Agreement,” and together, the “Australian Security Agreements”);

WHEREAS, pursuant to the Australian Security Agreements, the Grantor executed and delivered a Confirmatory Grant of Security Interest in Trademarks made effective as of November 8, 2018 (the “Collateral Assignment”), granting the Secured Party a security interest in and lien on certain Trademark Collateral (as defined below);

WHEREAS, the Collateral Assignment was recorded with the United States Patent and Trademark Office against the Trademark Collateral identified on Exhibit A hereto on November 9, 2018, at Reel 6479, Frame 0169; and

WHEREAS, the Grantor has satisfied all of the obligations under the Australian Security Agreements and has requested that the Secured Party terminate and release its security interests in and liens on the Trademark Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agrees as follows:

1. Definitions. Capitalized terms used herein without definition are used as defined in the Australian Security Agreements.

2. Release of Security Interest. The Secured Party hereby (i) terminates the Collateral Assignment, and (ii) terminates, releases, discharges and cancels any and all security interest in and liens pursuant to the Australian Security Agreements and the Collateral Assignment, including on the following Collateral of the Grantor (collectively, the “Trademark Collateral”):

all of the Trademarks set forth in Exhibit A, including all goodwill associated with such Trademarks and the business in which they are used and all common law rights related thereto, and all rights to sue at law or in equity for any infringement or other impairment thereof, including the right to receive all proceeds and damages therefrom (collectively, the “Released Trademark Collateral”).

3. Reassignment. The Secured Party hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by the Grantor, all of the Grantor’s right, title and interest in and to the Released Trademark Collateral.
