Assignor hereby irrevocably sells, assigns, and transfers to Assignee, its successors and assigns, all of Assignor's right, title, and interest in and to the Domain Names, and hereby irrevocably consents and authorizes the Registrar to transfer these Domain Names to Assignee in accordance with its regular transfer procedures.
