Assignor hereby irrevocably sells, grants, conveys, transfers, delivers, assigns and sets over to Assignee, its successors and assigns, without any reservation of rights, all of Assignor's right, title and interest, in and to the Marks together with the goodwill of the business symbolized thereby, all applications and registrations for the Marks, and all actions and causes of action and rights to damages and profits, due or accrued, relating to the foregoing, currently owned or hereinafter acquired.




