## RELEASE OF TRADEMARK SECURITY AGREEMENT

This Release of Trademark Security Agreement (this "Release") is made as of September 19, 2022, by **WEBSTER BANK, NATIONAL ASSOCIATION**, as administrative agent and collateral agent (in such capacity, together with any of its permitted successors in such capacities, the "Administrative Agent") for the benefit of **PHONE2ACTION, INC.**, a Delaware corporation ("Borrower"), and **GOVPREDICT, INC.**, a Delaware corporation ("Gov"), and together with Borrower, collectively, the "Grantor"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement.

### W I T N E S S E T H:

WHEREAS, the Grantor and the Administrative Agent are parties to that certain (i) Guarantee and Collateral Agreement, dated as of November 6, 2020 (as amended, restated or otherwise modified through the date hereof, the "Security Agreement") and (ii) Trademark Security Agreement, dated as of November 6, 2020 (as amended, restated or otherwise modified through the date hereof, the "Trademark Security Agreement"), pursuant to which the Grantor has granted to the Administrative Agent for the benefit of the Secured Parties a lien on and security interest in all of the right, title and interest of the Grantor in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including the trademarks set forth on Schedule I hereto;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office (the "USPTO") on November 11, 2020 at Reel 7103 and Frame 0313; and

WHEREAS, the Grantor has requested that the Administrative Agent release, and the Administrative Agent is willing to release its lien on and security interest in, and any other right, title, and interest it may have in, to and under the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. The Administrative Agent does hereby (x) terminate, release and discharge the entirety of any and all liens or security interests that it may have in or to the Trademark Collateral, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement or Trademark Security Agreement in or to the Trademark Collateral, and any right, title or interest of the Administrative Agent in such Trademark Collateral shall hereby terminate, cease and become void and (y) terminate and cancel the Trademark Security Agreement. The Administrative Agent hereby assigns, transfers and conveys any and all right, title and interest of the Administrative Agent in the Trademark Collateral to the Grantor and authorizes the Grantor or the Grantor's authorized representative or designee to record this Release with the USPTO as evidence of such release and termination.


