RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (“Release”) is made as of this 15th day of September 2022, by Wilmington Trust, National Association, in its capacity as the administrative agent (the “Administrative Agent”) for the Secured Parties (as defined in the Security Agreement, as defined below), in favor of Alnylam Pharmaceuticals, Inc., a Delaware corporation (the “Grantor”).

WHEREAS, pursuant to that certain Trademark Security Agreement made by the Grantors in favor of the Administrative Agent (the “Security Agreement”) and recorded at Reel/Frame 6914/0897, a security interest was granted by the Grantor to the Administrative Agent in the trademarks and trademark applications shown on Schedule A attached hereto, together with any and all (a) rights and privileges arising under applicable legal requirements with respect to the use of any of the foregoing, (b) all goodwill of the business connected with the use thereof and symbolized thereby, (c) extensions and renewals thereof and amendments thereto, (d) proceeds, income, fees, royalties, damages and payments now and hereafter due and/or payable thereunder and with respect thereto, including damages, claims and payments for past, present or future infringements, dilutions or other violations thereof, (e) rights to sue for past, present and future infringements, dilutions or other violations thereof, and (f) rights corresponding thereto throughout the world (collectively, the “Trademark Collateral”), including the United States trademarks and trademark applications set forth in Schedule A hereto;

WHEREAS, the Administrative Agent now desires to terminate the Security Agreement and terminate, release and discharge its security interest in all Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby states as follows:

1. Release of Security Interest. The Administrative Agent, on its and the Secured Parties’ behalf, hereby terminates the Security Agreement and terminates, releases, cancels and discharges the collateral pledges, grants, liens and security interests granted by the Grantor in favor of the Administrative Agent in and to the Trademark Collateral.

3. Recordation of Release. The Administrative Agent understands and agrees that this Release may be recorded by or for the Grantor, or its successors or assigns, with the United States Patent and Trademark Office.

4. Governing Law. This Release shall be governed by, and construed and enforced in accordance with, the laws of the State of New York, excluding conflict of laws principles that would cause the application of laws of any other jurisdiction.
