**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (“Release”) is made as of this 19th day of September, 2022, by CRESCENT AGENCY SERVICES LLC, in its capacity as collateral agent (“Agent”), in favor of UNISON SOFTWARE, INC., UNISON MARKETPLACE, INC., and UNISON VIRTUAL ACQUISITION OFFICE, LLC (each, a “Grantor”, and collectively, “Grantors”).

WHEREAS, Grantors entered into that certain Intellectual Property Security Agreement, dated June 25, 2020, with Agent, notice of which was recorded with (i) the United States Patent and Trademark Office on June 25, 2020 at reel/frame 6979/0629, (ii) the United States Patent and Trademark Office on June 25, 2020 at reel/frame 053044/0836, and (iii) the United States Copyright Office on or around June 25, 2020 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Intellectual Property Security Agreement”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Intellectual Property Security Agreement.

WHEREAS, Grantors granted to Agent, under the terms of the Intellectual Property Security Agreement, a security interest in favor of Agent, in and to all of their right, title and interest in and to (i) the Patent Collateral, Trademark Collateral and Copyright Collateral of such Grantors, including without limitation the trademarks listed in Schedule A hereto, the patents listed in Schedule B hereto, and the copyrights listed in Schedule C hereto, (ii) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantors accruing thereunder or pertaining thereto, (iii) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, otherwise recover, such damages and (iv) any and all proceeds of, income, royalties and other payments now or hereafter due and payable with respect to

any and all of the foregoing or arising from any of the foregoing, in each case, excluding Excluded Property (collectively the “IP Collateral”).

WHEREAS, Agent has agreed to terminate and release its security interest in and to all such IP Collateral as herein provided.



If and to the extent that the Agent has acquired any right, title or interest in and to the IP Collateral of any Grantor, the Agent hereby assigns, transfers and conveys to each Grantor any interest in such IP Collateral to such Grantor.


