**CONFIRMATORY GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS**

THIS CONFIRMATORY GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (as the same may be amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “*Confirmatory Grant*”) is made effective as of June 24, 2022 by and from Citron Hygiene US Corp. (the “*Grantor*”), to and in favor of Canadian Imperial Bank of Commerce, for itself and as Agent (as defined in the Credit Agreement referenced below) for the Secured Parties (as defined in the Credit Agreement referenced below) (in such capacities, the “*Grantee*”).

WHEREAS, Citron Hygiene LP, as Borrower, Canadian Imperial Bank of Commerce, as Agent and the lenders from time to time party thereto (the “*Lenders*”) have entered into that certain Second Amended and Restated Senior Secured Credit Agreement, dated as of June 24, 2022 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “*Credit Agreement*”).

WHEREAS, the Grantor and certain other Subsidiaries of the Borrower have entered into a U.S. Pledge and Security Agreement dated as of June 24, 2022 (as may be amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “*U.S. Security Agreement*”).

WHEREAS, the Grantor owns the trademarks listed on Schedule A attached hereto (the “*Trademarks*”), which Trademarks are pending or registered with the United States Patent and Trademark Office.

WHEREAS, this Confirmatory Grant has been executed in conjunction with the security interest granted under the U.S. Security Agreement to the Grantee for the benefit of the Secured Parties. In the event that any provisions of this Confirmatory Grant are deemed to conflict with the U.S. Security Agreement, the provisions of the U.S. Security Agreement shall govern.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) Definitions. All capitalized terms not defined herein shall have the respective meaning given to them in the Credit Agreement.

2) The Security Interest.

(a) This Confirmatory Grant is made to secure the prompt and complete performance and payment of all the Secured Obligations (as defined in the U.S. Security Agreement).

(b) The Grantor hereby pledges and grants to the Grantee, on behalf of and for the benefit of the Secured Parties, a security interest in all of the Grantor’s right, title and interest, wherever located and whether now owned or hereafter acquired, in and to (1) its trademarks (including service marks), trade names, trade styles, trade dress and the registrations and applications for registration thereof, including the Trademarks and the goodwill of the business symbolized by the foregoing; (2) all renewals of the foregoing; (3) all income, royalties, damages, claims and payments now or hereafter due or payable with respect thereto, including, without limitation, damages, claims, and payments for past and future infringements thereof; (4) all rights to sue for past, present, and future infringements of the

foregoing, including the right to settle suits involving claims and demands for royalties owing and (5) all rights corresponding to any of the foregoing throughout the world.

3) Amendment and Restatement. This Confirmatory Grant amends and restates in its entirety the Confirmatory Grant of Security Interest in United States Trademarks dated July 17, 2019 between the partes hereto (the "*Existing Confirmatory Grant*"). The security interests granted by the Grantor, and security interests created, under the Existing Confirmatory Grant continue without interruption under this Confirmatory Grant and such security interests are hereby ratified and confirmed in all respects. From and after the effectiveness of this Confirmatory Grant, the Secured Obligations under the Existing Confirmatory Grant shall continue as Secured Obligations under the Loan Documents and this Confirmatory Grant, except to the extent such Secured Obligations are modified from and after the date hereof as provided in this Security Agreement. Without limiting the generality of the foregoing, this Confirmatory Grant and the other applicable Loan Documents and the grant of security interests on all of the Collateral described herein and therein do and shall continue to secure (without interruption) the payment of all Secured Obligations under the Loan Documents, in each case, as amended by this Confirmatory Grant. Nothing herein shall be construed as a novation of the obligations outstanding under, or the security interest created by or granted pursuant to, the Existing Confirmatory Grant, which shall remain in full force and effect, except as modified hereby. Nothing express or implied in this Agreement shall be construed as a release or discharge of any Grantor under the Existing Confirmatory Grant (other than as, and except to the extent set forth in this Confirmatory Grant).

4) Governing Law. **THIS CONFIRMATORY GRANT AND ANY CLAIMS, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS CONFIRMATORY GRANT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.**


