CONFIRMATORY TRADEMARK ASSIGNMENT

This Confirmatory Trademark Assignment (this "Assignment") is entered into as of the last date noted below, by and between **STRYKER EUROPEAN HOLDINGS I, LLC**, a limited liability company incorporated under the laws of the State of Delaware, having its principal place of business at 2825 Airview Boulevard, Kalamazoo, Michigan 49002, United States of America, acting in its capacity as managing partner of **STRYKER EUROPEAN TECHNOLOGIES C.V.**, a limited partnership established under the laws of the Netherlands ("commanditaire vennootschap"), having its registered office at Canon's Court, 22 Victoria Street, Hamilton, HM 12, Bermuda, (the "Assignor"), and **STRYKER EUROPEAN HOLDINGS IV, LLC**, a limited liability company incorporated under the laws of the State of Delaware, having its registered agent's address at The Corporation Trust Company, 1209 Orange Street, Wilmington, Delaware 19801, United States of America (the "Assignee"). Assignor and Assignee are collectively referred to as the "Parties" and individually referred to as a "Party."

WHEREAS, pursuant to an INTELLECTUAL PROPERTY TRANSFER AGREEMENT dated September 5, 2018, (the "Prior Agreement") and subsequent Amendment dated May 8, 2020, which are governed by the laws of the State of Michigan, U.S.A., Assignor assigned, transferred and conveyed all of its right, title and interest in and to, *inter alia*, (i) all of the trademarks, trademark applications and trademark registrations identified on Schedule A of this Assignment (the "Marks"), (ii) all legal equivalents of the Marks throughout the world, (iii) all common law rights and the goodwill of the business connected with the use of and symbolized by the Marks, in the United States and throughout the world and (iv) the right to sue and collect past damages in connection with the Marks, in the United States and throughout the world (i-iv collectively referred to as the "Trademark Rights"), and Assignee, as successor to Assignor's entire business or that portion of the business to which the Marks pertain, agreed to accept the Trademark Rights.

NOW, THEREFORE, both parties specify the consideration money has been already paid at the time of the deed of assignment, and therefore they ask the fiscal registration of this deed at fixed tax, the receipt whereof is acknowledged, the Parties also acknowledge the receipt and exchange of other good and valuable consideration associated with the Prior Agreement, which has been kept confidential, the receipt and sufficiency of which is hereby acknowledged, and the Parties hereby agree as follows:

1. To confirm the above-noted assignment pursuant to the Prior Agreement, as of September 5, 2018, nunc pro tunc, Assignor hereby assigns, transfers, conveys and sets over to the Assignee, its successors and assigns, and Assignee hereby accepts, all right, title and interest, in the United States and throughout the world, in and to the Trademark Rights, to have and to hold the same, unto Assignee for its own use and enjoyment and for the use and enjoyment of its successors and assigns, for the full term or terms of all such rights.

2. Assignor hereby agrees, without further consideration and without expense to the Assignor, to sign all documents and to perform all other lawful acts which the Assignee may reasonably request to make this Assignment of the Trademark Rights fully effective.

3. This Assignment shall be binding upon, inure to the benefit of, and be enforceable by, the Parties and their respective successors and permitted assigns.

4. This Assignment shall be governed by and construed in accordance with the laws of the State of Michigan, United States of America.

5. This Assignment may be executed and delivered (including electronically) in one or more counterparts, and by the Parties in separate counterparts, each of which when executed shall be deemed to be an original, but when taken together shall constitute one and the same agreement.

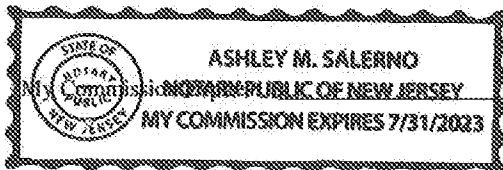

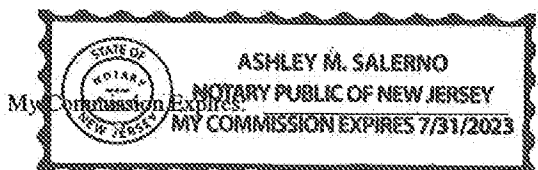
