## INTELLECTUAL PROPERTY SECURITY AGREEMENT

This **INTELLECTUAL PROPERTY SECURITY AGREEMENT**, dated as of September 16, 2022 (the "**Agreement**") between **WESTERN ALLIANCE BANK**, an Arizona corporation ("**Lender**") and **IDENT-A-KID SERVICES OF AMERICA, LLC**, a Delaware limited liability company ("**Grantor**") is made with reference to the Loan and Security Agreement, dated as of January 12, 2022 (as amended from time to time, the "**Loan Agreement**"), between, *inter alios*, Lender and Grantor. Terms defined in the Loan Agreement have the same meaning when used in this Agreement.

For good and valuable consideration, receipt of which is hereby acknowledged, Grantor hereby covenants and agrees as follows:

To secure the Obligations under the Loan Agreement, Grantor grants to Lender a security interest, pursuant to the Loan Agreement, in all right, title, and interest of Grantor in any of the following, whether now existing or hereafter acquired or created in any and all of the following property (collectively, the "**Intellectual Property Collateral**"):

- (a) the copyright rights, copyright applications, copyright registrations and like protections in each work or authorship and derivative work thereof listed on **Exhibit A** hereto;
- (b) the trademark and servicemark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of the Grantor connected with and symbolized by such trademarks listed on **Exhibit B** hereto; and
- (c) the patents, patent applications and like protections including without limitation improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same listed on **Exhibit C** hereto.

This Agreement has been executed and delivered by Grantor for the purpose of registering the security interest of Lender in the Intellectual Property Collateral with the United States Patent and Trademark Office and/or Copyright Office, as applicable. The security interest granted hereby has been granted as a supplement to, and not in limitation of, the security interest granted to Lender for its benefit under the Loan Agreement. The Loan Agreement shall remain in full force and effect in accordance with its terms.


