**TERMINATION AND RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of September 20, 2022 (“Release”), is made by HAYFIN SERVICES LLP, a United Kingdom limited liability partnership, as administrative agent for the Secured Parties (the “Agent”) in favor of HYLAND’s CONSUMER HEALTH, INC. F/K/A STANDARD HOMEOPATHIC COMPANY, a Nevada corporation, and WALKER LABORATORIES, INC., a Missouri corporation (collectively, the “Grantor”).

WHEREAS, pursuant to that certain Security Agreement dated as of July 31, 2020 (as amended or otherwise modified from time to time, the “Security Agreement”) by and among the Grantor, the Agent, the Secured Parties, and others party thereto, Grantor granted to the Agent, for the ratable benefit of the Secured Parties, a security interest in all Patent Collateral, Trademark Collateral, and Copyright Collateral, including, but not limited to, the patents, copyrights, and trademark registrations and applications for the foregoing listed on Schedule A attached hereto (collectively, “Intellectual Property Collateral”); and

WHEREAS, pursuant to the Security Agreement, Grantor executed and delivered to Agent the (i) U.S. Patent Security Agreement dated as of July 31, 2020 and recorded at the United States Patent and Trademark Office (“USPTO”) on July 31, 2020 at Reel 053369 Frame 0974 (“Patent Security Agreement”), (ii) Trademark Security Agreement dated as of July 31, 2020 and recorded at the USPTO on August 4, 2020 at Reel 7015 Frame 0018 and on August 4, 2020 at Reel 7015 Frame 0040 (“Trademark Security Agreement”), (iii) Trademark Security Agreement dated December 22, 2021 and recorded at the USPTO on December 23, 2021 at Reel 7541 Frame 0286 (“Supplemental Trademark Security Agreement”) and (iv) Copyright Security Agreement dated as of July 31, 2020 and filed at the United States Copyright Office (“USCO”) and pending recordation (“Copyright Security Agreement”, and together with the Patent Security Agreement, Trademark Security Agreement, and Supplemental Trademark Security Agreement, collectively, the “IP Security Agreements”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or IP Security Agreements.

SECTION 2. Termination and Release. Agent, without representation, warranty, or recourse, hereby:

- (a) terminates, cancels, discharges, and releases the security interest in all the Intellectual Property Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or IP Security Agreements;

- (b) authorizes the recordation of this Release with the USPTO, USCO, and any other governmental authority, at Grantor's expense; and
- (c) agrees to provide the Grantor with any information and additional authorization reasonably necessary to effect the release of the Grantor's security interest in the Intellectual Property Collateral.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Agent has caused this Termination and Release of Security Interest in Intellectual Property to be duly executed as of the date first set forth above.
