# **GRANT OF SECURITY INTEREST**

## **TRADEMARKS**

THIS GRANT OF SECURITY INTEREST, dated as of September 19, 2022, is made by and between JEUNESSE GLOBAL HOLDINGS, LLC, a Florida limited liability company (the “Grantor”) in favor of MARKET Q, INC., a Florida corporation (the “Secured Party”).

WHEREAS, the Grantor has executed and delivered to the Secured Party a certain Security Agreement dated as of September 19, 2022, made by and between the Grantor and the Secured Party (the “Security Agreement”).

WHEREAS, under the terms of the Security Agreement, the Grantor has granted to the Secured Party a security interest in, among other property, certain intellectual property of the Grantor, and has agreed to execute and deliver this Grant of Security Interest for recording with the United States Patent and Trademark Office.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Grant of Security. Grantor hereby pledges and grants to the Secured Party a security interest in and to all of the right, title, and interest of Grantor in, to, and under the following (the “Trademark Collateral”):

the trademark registrations and applications set forth in Schedule 1 hereto, together with the goodwill connected with the use of and symbolized thereby, and all extensions and renewals thereof (the “Trademarks”);

all rights of any kind whatsoever of Grantor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

any and all claims and causes of action, with respect to any of the foregoing, whether occurring before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right, but no obligation, to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

Recordation. Grantor authorizes the Commissioner for Trademarks to record and register this Grant of Security Interest upon request by the Secured Party.

Supplemental Documents. This Grant of Security Interest has been entered into pursuant to and in conjunction with the Security Agreement, which is hereby incorporated by reference. The provisions of the Security Agreement shall supersede and control over any conflicting or

inconsistent provision herein. The rights and remedies of the Secured Party with respect to the Trademark Collateral are as provided by the Security Agreement and related documents, and nothing in this Grant of Security Interest shall be deemed to limit such rights and remedies.

Execution in Counterparts. This Grant of Security Interest may be executed in counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page to this Grant of Security Interest by facsimile or in electronic (i.e., “pdf” or “tif” format) shall be effective as delivery of a manually executed counterpart of this Grant of Security Interest.

Successors and Assigns. This Grant of Security Interest will be binding on and shall inure to the benefit of the parties hereto and their respective successors and assigns.

Governing Law. This Grant of Security Interest and any claim, controversy, dispute, or cause of action (whether in contract or tort or otherwise) based upon, arising out of, or relating to this Grant of Security Interest and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Florida, without giving effect to any choice or conflict of law provision or rule (whether of the State of Florida or any other jurisdiction).
