Assignment

WHEREAS, Assignor desires to assign any and all right, title and interest in and to said mark, said Trademark Application and any registered trademark which may grant from said Trademark Application (hereinafter referred to as a "Trademark"), and including that portion of Assignor's business to which the mark pertains and any and all goodwill and other benefits accruing to or to accrue to Assignor with respect to said mark, said Trademark Application and said Trademark in the United States and its territorial possessions, and in any foreign countries and regions (hereinafter collectively referred to as the "Trademark Rights"); AND

WHEREAS, Universal Tech Corporation, a corporation organized and existing under the laws of the State of Delaware, and having its principal place of business at 15833 W Judd Street, Ettrick, Wisconsin 54627 (hereinafter referred to as "Assignee"), is desirous of acquiring the entire right, title and interest of Assignor in and to said Trademark Rights in the United States of America and its territorial possessions, and in any and all foreign countries and regions.

NOW, THEREFORE, for the sum of \$1.00 and other good and valuable consideration to Assignor, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns and transfers to said Assignee any and all of the entire right, title and interest whatsoever in and to said Trademark Rights in the United States of America and its territorial possessions and in any and all foreign countries and regions, with no reservation of any of such right, title and interest whatsoever.

Assignor hereby agrees and covenants that said Assignor is the owner and sole applicant named in said Trademark Application and said Trademark having all rights, interest, and title to assign said Trademark Rights to Assignee and that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment and sale.

Assignor further agrees and covenants that said Assignor will promptly provide Assignee, upon written request, with all pertinent facts and documents relating to said Trademark Rights, and legal equivalents in foreign countries, as may be known and accessible to Assignor, and that Assignor will promptly execute and deliver to Assignee or its legal representatives any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue, extend, expand, enforce and transfer ownership of said Trademark Rights, and said equivalents thereof in any foreign country and region, which may be necessary or desirable to carry out the purposes thereof.

Assignor further agrees and covenants to: (a) cooperate with Assignee in the protection and enforcement of said Trademark Rights, and any prosecution and protection of foreign counterparts; (b) execute, verify, acknowledge and deliver all such further papers, including those relating to said Trademark Rights and instruments of transfer, (c) communicate any facts known to Assignor respecting

said Trademark Rights, (d) testify in any legal proceeding relating to said Trademark Rights, (e) make all rightful oaths, and (f) perform such other acts as Assignee may lawfully request in order to obtain, maintain, expand, protect or enforce said Trademark Rights in the United States of America and its territorial possessions and in any and all foreign countries and regions.

Assignor hereby authorizes said Assignee, its successors and assigns, or anyone it may properly designate, to apply for expansion of the Trademark Rights in the United States of America and its territorial possessions and in any and all foreign countries and regions, in its own name if desired, and to take advantage of the provisions of any international conventions.

Assignor requests the United States Patent and Trademark Office to issue any Trademark Registration of the United States of America and any correspondence relating to said mark, said Trademark Application, said Trademark and any other of said Trademark Rights to said Assignee, its legal representatives, successors or assigns, as the sole owner of the entire right, title, and interest in said mark, said Trademark Application, said Trademark and any other of said Trademark Rights.

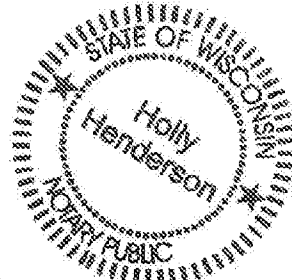
