SUPPLEMENTAL GRANT OF SECURITY INTEREST  
IN TRADEMARKS

August 11, 2022

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, the undersigned (the “Grantor”), hereby grants to BANK OF AMERICA, N.A., as Administrative Agent and Collateral Agent for its own benefit and the benefit of the other Credit Parties (as defined in the Security Agreement referred to below), having an office at 100 Federal Street, 9<sup>th</sup> Floor, Boston, Massachusetts 02110 (the “Grantee”), a continuing security interest in the following: (i) all the Grantor’s right, title and interest in, to and under the trademarks, service marks, trademark registrations, service mark registrations, trademark applications, and service mark applications set forth on Schedule A attached hereto (the foregoing, collectively, the “Marks”), (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same; provided however that this shall not include any Marks that are included in clause (b) of the definition of “Excluded Property” (as defined in the Security Agreement referred to below); provided further that such “intent-to-use trademark” applications shall remain Excluded Property only until a statement of use or amendment to allege use is filed and accepted by the United States Patent and Trademark Office or any other filing is made or circumstances otherwise change so that the interests of the Grantor in such marks is no longer on an “intent-to-use” basis.

THIS SUPPLEMENTAL GRANT OF SECURITY INTEREST IN TRADEMARKS (this “Grant”) is made to secure the satisfactory performance and payment of all the Secured Obligations of the Grantor, as such term is defined in the Security Agreement by, among others, the Grantor, the other Grantors party thereto (as defined therein), and the Grantee,

dated as of April 30, 2021 (as amended, modified, supplemented or restated hereafter, the "Security Agreement").


