**Agreement Between Good Health Teas and Edom Laboratories**

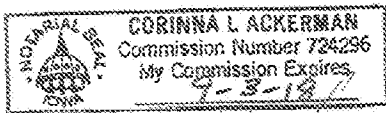
This is an Agreement between Good Health Teas, the Seller, and Edom Laboratories the Buyer,

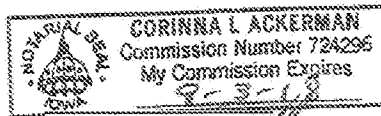
