**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of September 20, 2022 (“Release”), is made by BSP Agency LLC, a Delaware LLC, as Administrative Agent (“Administrative Agent”) in favor of Tillamook Country Smoker, LLC, a Delaware limited liability company (“Grantor”).

**WHEREAS**, pursuant to that certain Credit Agreement dated as of May 19, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”) by and among the Grantor, Administrative Agent, and others party thereto, certain other Security Documents, and the Trademark Security Agreement dated as of May 19, 2017 by and among the Grantor and Administrative Agent (“Trademark Security Agreement”), Grantor granted to the Administrative Agent, for its benefit and the benefit of the Lenders, a continuing security interest in Grantor’s entire right, title and interest in and to the Trademark Collateral; and

**WHEREAS**, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on May 24, 2017 at Reel 6067 Frame 0853.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of itself and the Lenders, and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Credit Agreement or Trademark Security Agreement.

**SECTION 2. Termination and Release.** Administrative Agent, on behalf of itself and the Lenders, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in Grantor’s entire right, title and interest in and to the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Credit Agreement, Security Documents, or Trademark Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.


**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.
