TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (the "Release") is made on this 7th day of September, 2022 by PINNACLE BANK (the "Lender").

WHEREAS, pursuant to that certain Amended and Restated Trademark Security Agreement, dated as of October 30, 2020 (the "Trademark Security Agreement"), by and among LOW-T CENTERS, INC., a Delaware corporation, LOW-T IP HOLDINGS, LLC, a Wyoming limited liability company and HER KARE HOLDINGS, LLC, a Texas limited liability company (jointly and severally, the "Grantors") and the Lender, the Grantors granted to the Lender a security interest in certain Trademarks (as defined in the Trademark Security Agreement), including the Trademarks identified on Exhibit A. Capitalized terms used herein but not otherwise defined shall have the meaning given to such terms in the Trademark Security Agreement;

WHEREAS, the security interest granted to the Lender under the Trademark Security Agreement was recorded at the United States Patent and Trademark Office on November 30, 2020, at Reel 7118 and Frame 0552; and

WHEREAS, the Lender has agreed to terminate the Trademark Security Agreement and release all of its interest in and to all of the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Trademark Security Agreement is hereby immediately and irrevocably terminated in its entirety and Lender hereby terminates and releases all mortgages, liens, security interests and any other rights that are or may have been granted to the Lender in and to the Trademarks, including without limitation, any Trademarks identified on Exhibit A.
