TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") is made and entered into as of September 26, 2022 (the "Effective Date"), by and between **Asplundh Investments, LLC**, a Delaware limited liability company having a place of business at 1100 N. 1. **ASSIGNMENT**: Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all of Assignor's right, title, and interest in and to the Trademark, together with the goodwill connected with the use of, and symbolized by, the Trademark.
2. **CONTINUING OBLIGATIONS**:
 - a. Assignor agrees to assist Assignee, upon request and at Assignee's expense, by taking any reasonable action that may be necessary for the perfecting, securing or completing of the assignment of the Trademark to Assignee.
 - b. Assignor hereby authorizes the Commissioner for Trademarks of the United States Patent and Trademark Office to record and register this Assignment upon request by Assignee.
3. **BINDING EFFECT**: The covenants and conditions contained in this Assignment shall be binding on Assignor and Assignee and on those who succeed to the interest of Assignor and Assignee by law, by approved assignment, or by transfer.
4. **COUNTERPARTS**: This Assignment may be executed in any number of counterparts each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
5. **GOVERNING LAW**: This Assignment shall be governed by and construed in accordance with the laws of the State of Delaware, excluding conflicts of laws provisions.
