**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of September 22, 2022, and made by **PNC BANK, NATIONAL ASSOCIATION**, as agent for certain lenders (the "Grantee"), to **HEALTHCAST, INC.**, a Delaware corporation (the "Grantor").

WHEREAS, pursuant to that certain (i) Assignment of Trademark Security Agreement dated as of May 8, 2019, made by Saratoga Investment Corp. SBIC LP, a Delaware limited partnership ("Saratoga"), in favor of Grantee (the "Assignment"), and (ii) Notice of Grant of Security Interest in Intellectual Property, made by the Grantor in favor of Saratoga (the "Notice of Security Agreement"), a security interest was granted to Grantee in the Intellectual Property (as hereinafter defined);

WHEREAS, the Notice of Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on July 5, 2018, at Reel/Frame 006372/0899;

WHEREAS, Grantee now desires to terminate the Notice of Security Agreement and terminate, release and discharge its security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Intellectual Property," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the intellectual property listed on Exhibit A hereto.

2. Release of Security Interest. Grantee hereby terminates the Notice of Security Agreement and terminates, releases and discharges its security interest in the Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Intellectual Property.
