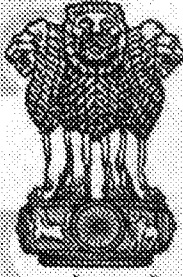

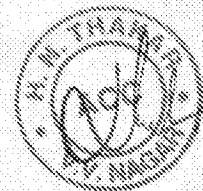

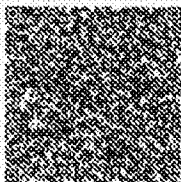

Mrs. Nilam Kirit Devidas Shah (Pan : AGTPS8803Q), wife of Kirit Devidas Shah, aged about 54 years, residing at "Shantam" Bungalow, Near Abhishek Tenament, Opp. Sattavis Gam Patidar School, Anand – 388001 (Hereinafter to be called the "Third Party").





NOW THIS DEED WITNESSES that in pursuance of the said agreement, it is hereby declared and agreed by and between the parties hereto as follows, that is to say:

1. DISSOLUTION BY MUTUAL AGREEMENT :-The said partnership between the partners hereto under the deed dated 01/04/2005 shall be determined and stand dissolved as from the 31st March, 2022.
2. USE OF THE SAME FIRM NAME :- The parties hereto singly or jointly shall not carry on the business of the said firm of M/s. Rainbow International.
3. SETTLEMENT OF PARTNERS ACCOUNT :
 - 3.1) Within 180 days after the dissolution of the partnership, a full and final books of accounts will be prepared and a balance sheet as on 31/03/2022 shall be taken and made of the property, assets and liabilities of the partnership firm and also a full and particular inventory and valuation of all the machinery, plants, tools, stock in hand, office equipment, materials and effects belonging to the firm shall be made by the parties and all debt showing to the firm shall be collected.
 - 3.2) That as soon as may be, after the property, assets and liabilities have been got in and disbursed, the parties under the foregoing clause shall divide and apportion the share of the parties in the proportion of the contribution of the parties towards the capital. In such division any amounts paid earlier or due to the parties according to the books of the partnership shall be taken into account.
 - 3.3) That all the intellectual properties (IP rights) in the form of trade mark, copyright etc. owned and possessed by the partnership firm for





All the IP rights within India and out of India will be vested in the First Party i.e. Mr. Kirit Devidas Shah. It is further agreed that such IP rights will be as per the value by all partners of partnership firm only, if any.

- 3.4) That in case of the winding up, if the assets of the partnership are insufficient to meet the liabilities and debts of the partnership then the partners shall forthwith pay such losses in the proportion of their contribution to the capital.
- 3.5) The First Party i.e. Mr. Kirit Devidas Shah is entrusted to carry out all the relevant transaction to give effect to the dissolution of the partnership firm and closure of the business. He is empowered to take all decisions in this regards and to act as an authorized signatory in all documents requiring signature as a partner and to do all acts, deeds and take all actions he deem fit in relation to the dissolving partnership firm. His actions will be binding to all the parties to this deed.




