RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST (“**Release**”) is made and effective as of December 8, 2016 and granted by RFC Al-Jon Lender, LLC, a Colorado limited liability company (“**RFC Al-Jon**”), in favor of C&C Manufacturing, LLC, an Iowa limited liability company (“**C&C**”) and its successors, assigns and legal representatives.

WHEREAS, pursuant to that certain Credit and Security Agreement, dated as of January 7, 2011 (the “**Security Agreement**”) between Al-Jon Manufacturing, LLC, a Delaware limited liability company (“**Grantor**”) and Cole Taylor Bank, an Illinois banking corporation (“**CTB**”), Grantor and CTB executed that certain Grant of Security Interest in Trademarks and Patents on January 7, 2011 (“**IP Grant**”);

WHEREAS, as a part of the Security Agreement, Grantor pledged and granted to CTB for the ratable benefit of CTB a security interest in and to all of the right, title, and interest of Al-Jon in, to, and under the Trademark Collateral (as defined below);

WHEREAS, the IP Grant was recorded with the United States Patent and Trademark Office (“**USPTO**”) at Reel 004503, Frame 0881 on March 23, 2011;

WHEREAS, MB Financial Bank, N.A., an Illinois bank (“**MB Financial**”), acquired, and became the successor in interest to CTB on August 18, 2014;

WHEREAS, MB Financial assigned its rights and obligations under the Security Agreement to RFC Al-Jon on December 8, 2016;

WHEREAS, Grantor, through RFC Al-Jon acting on behalf of Grantor, conveyed, transferred, and assigned to C&C all of Grantor’s right, title, and interest in and to the Trademark Collateral (as defined below) in that certain Trademark Assignment dated February 7, 2022 and filed with the USPTO at Reel 007638, Frame 0325 on February 18, 2022;

WHEREAS, RFC Al-Jon, as the assignee of CTB and MB Financial’s rights and obligations under the Security Agreement, and C&C have entered into this Release in order to effectuate, evidence, and record the release and reassignment to C&C of any and all right, title, and interest RFC Al-Jon may have in the Trademark Collateral;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, RFC Al-Jon hereby states as follows:

1. Release of Security Interest. RFC Al-Jon, as the assignee of CTB and MB Financial’s rights and obligations under the Security Agreement, their successors, legal representatives, and assigns, hereby terminates the IP Grant and terminates, releases, and discharges any and all security interests that it has pursuant to the Security Agreement in any and all right, title, and interest of C&C, and reassigns to C&C any and all right, title, and interest that it may have in, to, and under the following (collective, the “**Trademark Collateral**”):

(a) the trademark registrations and applications set forth in Schedule 1 hereto, together with any common law rights and the goodwill connected with the use thereof

and symbolized thereby, and all issuances, extensions, and renewals thereof (“Trademarks”);

(b) all rights of any kind whatsoever of C&C accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(c) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(d) any and all claims and causes of action, with respect to any of the foregoing, whether occurring before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Assurances. RFC Al-Jon hereby authorizes the Commissioner for Trademarks in the USPTO and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Release upon request by C&C. Following the date hereof, upon C&C’s reasonable request, RFC Al-Jon shall take such steps and actions, and provide such cooperation and assistance to C&C and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, or perfect the release of the Trademark Collateral and reassignment to C&C of any right, title, and interest in, to, and under the Trademark Collateral.

3. Governing Law. This Release and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Colorado, without giving effect to any choice or conflict of law provision or rule (whether of the State of Colorado or any other jurisdiction).

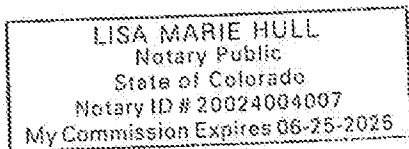
