ServiceSource International, Inc., a Delaware corporation (the “**Company**”), does hereby certify to the following facts relating to the merger (the “**Merger**”) of Concentrix Merger Sub, Inc., a Delaware corporation (“**Acquisition Sub**”), with and into the Company, with the Company remaining as the surviving corporation of the Merger (the “**Surviving Corporation**”):

- FIRST:** The Company’s name is ServiceSource International, Inc. and it is the Surviving Corporation. Acquisition Sub’s name is Concentrix Merger Sub, Inc. and it is being merged into the Surviving Corporation. The Company and Acquisition Sub are the constituent corporations in the Merger.
- SECOND:** An Agreement and Plan of Merger has been approved, adopted, certified, executed and acknowledged by the Company and by Acquisition Sub in accordance with Section 251(c) of the General Corporation Law of the State of Delaware (the “**DGCL**”).
- THIRD:** The name of the Surviving Corporation shall be Concentrix ServiceSource Inc.
- FOURTH:** The Certificate of Incorporation of the Surviving Corporation shall be its Certificate of Incorporation, except as amended in Article Third above.
- FIFTH:** The executed Agreement and Plan of Merger is on file at the principal place of business of the Surviving Corporation at 39899 Balentine Drive, Suite 235, Newark, CA 94560.
- SIXTH:** A copy of the executed Agreement and Plan of Merger will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of any constituent corporation of the Merger.
- SEVENTH:** The Merger shall become effective immediately upon filing of this Certificate of Merger with the Secretary of State of the State of Delaware in accordance with Sections 103 and 251(c) of the DGCL.
