TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "Agreement") is made and entered into as of October 1, 2021, by and among Lykins Companies, Inc., an Ohio corporation, and Lykins Oil Company, an Ohio corporation (together, the "Assignor"), and World Fuel Services, Inc., a Texas corporation (the "Assignee").

WITNESSETH

WHEREAS, the Assignor and the Assignee have entered into the Asset Purchase Agreement, dated as of September 27, 2021 (the "Purchase Agreement"), pursuant to which the Assignee has acquired all of the Assignor's right, title and interest in and to the trademark registrations listed on Schedule A hereto (the "Trademarks").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor and the Assignee each hereby agree as follows:

A. Purpose and Definitions. This Agreement is executed and delivered pursuant to the Purchase Agreement. All capitalized terms used and not otherwise defined herein shall have the meanings ascribed to them in the Purchase Agreement.

B. Assignment. The Assignor hereby sells, assigns, transfers, conveys and delivers to the Assignee and its successors and assigns, and the Assignee hereby purchases and accepts from the Assignor, all of the Assignor's right, title and interest in, to and under the Trademarks, free and clear of all Liens, including, without limitation, all goodwill associated therewith or symbolized thereby, all common law trademark rights related thereto, together with the right to sue and recover damages for future, present and past infringements thereof and to fully and entirely stand in the place of the Assignor in all matters related thereto, including the right to any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing. This Agreement is intended to be an absolute assignment and not by way of security.


