## ASSIGNMENT OF TRADEMARK RIGHTS

THIS AGREEMENT ("Agreement") is entered into as of date set forth below, by and between Living Art-N-Life, a Wisconsin company solely owned by Mark L. Anderson, an individual, having an address at 303 S. McKay Avenue, Spring Valley, Wisconsin 54767 ("Assignor"), and Mark L. Anderson, LLC, a Wisconsin limited liability company, having its principal place of business at 303 S. McKay Avenue, Spring Valley, Wisconsin 54767 ("Assignee").

### WITNESSETH:

WHEREAS, Assignor has adopted, used and is using the mark listed in Schedule A hereto;

WHEREAS, Assignor has a registration for the mark or application therefor, as listed in Schedule A;

WHEREAS, Assignee is desirous of acquiring any and all rights that Assignor may have in and to said mark listed in Schedule A, and any and all registrations and applications for registrations pertaining to such mark, together with the goodwill of the business in connection with which said mark is used and which is symbolized by said mark.

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which are acknowledged, Assignor and Assignee do hereby agree as follows:

1. **Assignment of Rights.** Assignor hereby assigns, sells and transfers unto Assignee all right, title and interest in and to said mark and any and all registrations and applications for registration therefor, together with the good will of the business in connection with which said mark is used and which is symbolized by said mark, along with the right to recover for damages and profits for past infringements thereof.

2. **Consideration for Assignment.** Assignee shall pay Assignor the sum of \$1.00 and other good and valuable consideration.

3. **Miscellaneous.** This Agreement shall be construed and interpreted in accordance with the laws of the State of Wisconsin. The parties mutually agree that this Agreement contains the final and entire agreement between the parties. This Agreement shall not be changed in its terms by any oral agreement or representation, but only in writing and executed by both parties. The provisions of this Agreement shall be severable. The subject headings of the sections of this Agreement are for convenience only and will not affect the construction or interpretation of any of its provisions. No failure or delay by either party in exercising any right, power or privilege under this Agreement will operate as a waiver thereof, nor will any single or partial exercise thereof preclude any other or further exercise of any right, power or privilege hereunder. Any and all schedules, exhibits and other documents which are attached to and referred to in this Agreement are incorporated herein and made a part hereof by

reference. The provisions of this Agreement shall be binding upon and inure to the benefit of the parties, and their respective heirs, successors in interest, legal representatives and assigns.
