**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this “Release”) is made as of September 15, 2022 (“Effective Date”) by Fortress Credit Co LLC, as administrative agent (in such capacity, together with its successors and permitted assigns, the “Agent”) in favor of Silver Cinemas Acquisition Co. and Truly Indie LLC (each, a “Grantor” and collectively, the “Grantors”). Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed to such terms in the Guaranty and Security Agreement (as defined below) (or if not defined therein, the Trademark Security Agreement (as defined below)).

**WHEREAS**, Grantor, the Agent, and certain other parties entered into that certain Guaranty and Security Agreement dated December 3, 2018 (the “Guaranty and Security Agreement”), and pursuant to the terms and conditions of the Guaranty and Security Agreement, that certain Trademark Security Agreement dated December 3, 2018 (the “Trademark Security Agreement”) was recorded with the United States Patent and Trademark Office on December 4, 2018 at Reel 006540, Frame 0720;

**WHEREAS**, pursuant to the terms and conditions of the Trademark Security Agreement, Grantor granted to the Agent a security interest in all of Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement); and

**WHEREAS**, Grantor has satisfied the terms of the Guaranty and Security Agreement and requests a specific release of the security interest granted and recorded against the Trademark Collateral, and the Agent now desires to release its security interest in all of Grantor’s right, title and interest in, to and under the Trademark Collateral, including, without limitation, the trademark registrations listed on Schedule 1 hereto.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby: (i) terminates and releases its security interest in all of Grantor’s right, title and interest in, to and under the Trademark Collateral, including, without limitation, the trademark registrations listed on Schedule 1 hereto; and (ii) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of the Agent’s rights under the Guaranty and Security Agreement and/or Trademark Security Agreement, in each case with respect to the Trademark Collateral.


This Release may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
