RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”) is made as of this 29th day of September, 2022, by Bank of America, N.A., as Administrative Agent (“Agent”), in favor of GHS Interactive Security, LLC, a Delaware limited liability company (“Grantor”).

WHEREAS, pursuant to the Notice of Grant of Security Interest in Trademarks, dated as of July 2, 2018 (the “Trademark Security Agreement”), a continuing security interest in and continuing lien (the “Security Interest”) was granted by Grantor to Agent in certain trademarks and trademark applications, including the trademarks listed on Schedule A attached hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“USPTO”) on July 2, 2018 at Reel/Frame 6370/0138; and

WHEREAS, Agent now desires to terminate and release the entirety of the Trademark Security Agreement and its Security Interest in the Trademark Collateral, including those trademarks listed on Schedule A attached hereto.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, Agent hereby agrees as follows:

1. Release of Security Interest. Agent hereby (i) terminates the Security Agreement and (ii) terminates, releases and discharges and reassigns to Grantor any and all Security Interests granted by Grantor in favor of Agent in, all of its right, title, and interest in and to the following Trademark Collateral of Grantor:

(a) all of its trademarks and trademark applications, including, without limitation, those trademarks referred to on Schedule A hereto;

(b) all renewals and extensions of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each such trademark; and

(d) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof (collectively, the “Trademark Collateral”).

2. Any right, title or interest of Agent in, to, and under such Trademark Collateral shall hereby cease and become void.

3. Recordation. Agent hereby authorizes Grantor and their designees to record this Release with the USPTO or any other applicable governmental authority at Grantor’s expense.
