SUPPLEMENT NO. 1 TO
INTELLECTUAL PROPERTY SECURITY AGREEMENT

This SUPPLEMENT NO. 1 TO INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Supplement"), dated as of April 1, 2022, is made by THE HC COMPANIES, INC., a corporation formed under the laws of the State of Delaware (the "Grantor"), in favor of PNC Bank, National Association, as Agent for the Lenders party from time to time to that certain Revolving Credit, Term Loan and Security Agreement, dated as of February 17, 2015 (as amended from time to time, the "Credit Agreement"), by and among the Grantor, certain Affiliates of the Grantor, the Agent and the Lenders. Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Credit Agreement or the IP Security Agreement (as defined below), as applicable.

Grantor executed that certain Intellectual Property Security Agreement, dated as of February 17, 2015, in favor of Agent, as acknowledged and agreed by Agent and as recorded with the United States Patent and Trademark Office on February 23, 2015 at Reel 005464, Frame 0398, with respect to the Trademarks, and Reel 035004, Frame 0319, with respect to the Patents, (as it may from time to time be further amended, restated, amended and restated, supplemented, extended, joined or otherwise modified from time to time, the "IP Security Agreement").

Grantor hereby confirms the grant to the Agent, for the benefit of the Agent and the Lenders, on the same terms as set forth in the IP Security Agreement, of a continuing security interest in and Lien upon all of Grantor's right, title and interest in and to its Collateral, in each case whether now or hereafter existing or in which Grantor now has or hereafter acquires an interest and wherever the same may be located.

Grantor hereby agrees that (i) the attached Schedule A shall constitute part of and an addition to Schedule A to the IP Security Agreement and (ii) each other provision of the IP Security Agreement is hereby incorporated *mutatis mutandis*.



