**TERMINATION AND RELEASE
OF GRANT OF SECURITY INTEREST (TRADEMARKS)**

TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST (TRADEMARKS) (“Release”), dated as of September [28], 2022, by **WEBSTER BANK, NATIONAL ASSOCIATION** (the “Lender”), in favor of **PALLADIO BEAUTY GROUP, LLC**, a Delaware corporation, **PALLADIO BEAUTY GROUP HOLDINGS, INC.**, a Delaware corporation (the “Grantors”).

WHEREAS, pursuant to the terms of that certain Intellectual Property Security Agreement, dated as of April 13, 2012 (as amended supplement or otherwise modified from time to time, the “IP Security Agreement”), between the Grantors and the Lender, the Grantors granted to the Lender a security interest in and to all of the right, title and interest of the Grantors in and to the trademark listed on Schedule A attached hereto, which trademark is registered in the United States Patent and Trademark Office (the “Trademarks”), together with the goodwill of the business symbolized by the Trademark, and all proceeds thereof, including, without limitation, from any and all causes of action which may exist by reason of infringement thereof (together with the Trademarks, the “Collateral”), to secure the prompt payment, performance and observance of the Obligations (as defined in the IP Security Agreement referred to in the Agreement);

WHEREAS, the Lender wishes to terminate and release its security interests in and to all of the right, title and interest of the Grantors in and to the Collateral, including the Trademark identified on Schedule A attached hereto; and

WHEREAS, the Agreement was recorded on April 26, 2012 with the United States Patent and Trademark Office at Reel: 4765; Frame: 0495.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby terminates, releases and discharges fully its security interests in and to all of the right, title and interest of the Grantors in and to the Collateral, as granted under the IP Security Agreement and the Agreement, and reassigns and transfers to the Grantors all right, title and interest that the Lender may have in the Collateral, and terminates the IP Security Agreement and the Agreement. The Lender hereby authorizes the Grantor, or the Grantor’s authorized representative, to record this Release with the United States Patent and Trademark Office.
