ASSIGNMENT OF SERVICE MARKS

THIS ASSIGNMENT OF SERVICE MARKS (this "Assignment"), dated as of September 1, 2021, is made by Stevens Holtze Corporation, a Colorado corporation ("Assignor"), to and in favor of CTH Acquisition LLC, a Delaware limited liability company ("Assignee").

Recitals

A. Assignor is the owner of the entire right, title and interest in and to certain service marks.

B. Assignor desires to assign its entire right, title and interest in and to such service marks, and Assignee desires to acquire Assignor's entire right, title and interest in and to such service marks, on the terms of this Assignment.

Agreements

Now, Therefore, for good and valuable consideration in the amount of \$10.00 US Dollars, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignment. Assignor hereby irrevocably conveys, transfers and assigns to Assignee all of Assignor's right, title and interest in and to the following (the "Assigned Service Marks"), together with all goodwill associated or connected with the use of, and symbolized by, the Assigned Service Marks:

(a) the service marks set forth on Schedule 1 hereto and all intellectual property rights associated therewith, whether registered, unregistered or arising by any applicable law of any jurisdiction throughout the world, all registrations and applications for registration of such service marks, including intent-to-use trademark applications, issuances, extensions and renewals of such registrations and applications, and similar intangible property and related proprietary rights, interests and protections, however arising, pursuant to any such law;

(b) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(c) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(d) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on and/or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages, together with all of the foregoing relating to the

cancellation proceeding with the Trademark Trial and Appeal Board (proceeding 92075684) captioned *Stevens Holtze Corporation DBA Magnolia Hotels v. Magnolia Medspa PC*.

2. Further Actions. To vest the Assigned Service Marks in Assignee and its successors and permitted assigns, Assignor will, and will cause its affiliates, successors and permitted assigns to, (a) execute and deliver such additional instruments of transfer and conveyance and other documents reasonably requested by Assignee and (b) take such other actions reasonably requested by Assignee.

3. Counterparts. This Assignment may be executed in one or more counterparts, each of which, when executed, will be deemed to be an original and all of which, when taken together, will be deemed to constitute one and the same instrument. A signed copy of this Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.

4. Successors and Assigns. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.




