NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby assigns and sells to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the Trademark and Registrations together with the goodwill symbolized by the Trademark and Registrations concurrent with the indicia of said goodwill.
