**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of September 19, 2022 by **SILICON VALLEY BANK**, as Administrative Agent (as defined in the Grant) (the “*Assignee*”), in favor of **QUORUM ANALYTICS, INC.**, a Delaware corporation (the “*Grantor*”).

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement dated as of November 30, 2021 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Grant*”) granting the Assignee a security interest in and lien on all of Grantor’s right, title and interest in, to and under its Intellectual Property (as defined in the Grant) (including without limitation those Copyrights, Patents, and Trademarks (in each case, as defined in the Grant) listed on Exhibits A, B, and C thereto), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), any goodwill associated therewith, the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof (collectively, “*IP*”) described therein, which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on November 30, 2021, at Reel 7510, Frame 0050;

WHEREAS, Grantor has requested that Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under the IP as herein provided; and

WHEREAS, Grantor has requested that the Assignee provide a document suitable for recording with the USPTO to evidence the release of the Assignee’s security interests in and liens on the IP as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:

1. terminates the Grant and releases, terminates and discharges all security interests in and liens on all of Grantor’s right, title and interest in, to and under the IP, including, without limitation, the IP identified in Schedule I hereto; and
2. authorizes Grantor (or its designee) to record and requests that this Termination and Release be recorded at the USPTO.

THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE INTERNAL LAWS (AND NOT THE CONFLICT OF LAW RULES) OF THE STATE OF NEW YORK.
