

And for said consideration, Trustee has sold, assigned and set over, and hereby does sell, assign and sent over unto Assignee, it's successors and assigns, any and all claims, demands or rights of action which Assignor has or might have to recover damages and profits, or either by reason of any infringement or infringements of the Trademark prior to the date of this Assignment, together with the right to Assignee, it's successors and assigns, to prosecute such demands or rights of action in its own name.

And, said Trustee hereby covenants that it has full right to convey the entire interests herein assigned, and that it has not executed, and will not executed, any agreements in contravention of the interests assigned herein.

Trustee further agrees that, at the request and expense of Assignee, its successors and assigns, Trustee will execute any further papers and do such other acts and things as may be necessary and proper to permit Assignee, its successors and assigns, to have said Trademark registered on the principal register of the United States Patent and Trademark Office and in such foreign countries as Assignee, it's successors and assigns may elect, and vest the full title in any and all such registrations in Assignee, it's successors and assigns.
