Lockstate, Inc., a corporation organized and existing under and by virtue of the Delaware General Corporation Law (the “Corporation”), does hereby certify:

FIRST: The name of the Corporation is Lockstate, Inc.

SECOND: The date on which the Certificate of Incorporation of the Corporation was originally filed with the Secretary of State of the State of Delaware is December 30, 2016. The date on which the Amended and Restated Certificate of Incorporation of the Corporation was originally filed with the Secretary of the State of Delaware is December 22, 2021.

THIRD: The Board of Directors of the Corporation, acting in accordance with the provisions of Sections 141 and 242 of the Delaware General Corporation Law, adopted resolutions amending its Certificate of Incorporation as follows:

Article First shall be amended and restated to read in its entirety as follows:
