RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of September 27, 2022 (the “Effective Date”) by WHITE OAK GLOBAL ADVISORS, LLC, a Delaware limited liability company, in its capacity as administrative agent for the Lending Parties (in such capacity, together with its successors and assigns in such capacity, “Agent”).

WHEREAS, reference is made to that certain Guaranty and Security Agreement, dated as of May 25, 2018 (as from time to time amended, restated, supplemented or otherwise modified, the “Guaranty and Security Agreement”) by and among HARDINGE INC. (“Grantor”), the other guarantors party thereto, and Agent;

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of May 25, 2018 (as amended, restated, supplemented, waived or otherwise modified from time to time, the “Trademark Security Agreement”), by and between Grantor and Agent, and certain other Loan Documents, Grantor granted to Agent a continuing security interest in all of such Grantor’s right, title and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 25, 2018 at Reel 6391, Frame 0796; and

WHEREAS, Agent has consented and hereby consents to the release of its continuing security interest in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby covenants and agrees as follows:

1. All capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Guaranty and Security Agreement.
2. Agent hereby discharges, terminates, and releases its continuing security interest in all right, title and interest in and to the Trademark Collateral granted pursuant to any Loan Document, including the Trademark Security Agreement, and agrees that all the security interest in the Trademark Collateral is hereby terminated and released.
3. To the extent Agent retains any right, title or interest in and to the Trademark Collateral, Agent hereby assigns, transfers, delivers and conveys to Grantor, all of Agent’s right, title and interest, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to the Trademark Collateral.
